

EDITORIAL GUIDELINES FOR CONFERENCE PROCEEDINGS FOR PUBLICATION IN IJOEHY – Italian Journal of Industrial and Environmental Hygiene

Scientific contributions for publication in the conference proceedings must be submitted, in their final version and in Word format, through the dedicated section of the website www.aidii.it related to the event.

The **title**, in Italian and English, must be sufficiently informative and must not exceed 180 characters, including spaces and punctuation.

Authors must be indicated with full first name and surname, separated by commas. Academic or professional titles (Dr., Prof., Eng., etc.), addresses, or telephone numbers must not be used.

The **affiliation reference number** must be indicated as a superscript to the right of the surname. Affiliations must be listed below the authors' names, preceded by the superscript number on the left, as shown in the following example:

Please also indicate the **corresponding author** and the **e-mail address**, and **up to 5 keywords**, avoiding the use of words already included in the title.

Each contribution must not exceed 4,000 characters, including spaces (approximately two pages, excluding title, authors' affiliations, tables, figures, and references). Contributions may be written in Italian or English.

The **text** should preferably be divided into the following sections:

- Introduction;
- Materials and methods;
- Results and discussion;
- Conclusions;
- References.

In-text citations must be enclosed in square brackets and must include the authors' surname(s) and the year of publication.

- In the case of two authors, indicate both surnames followed by the year of publication.
- In the case of three or more authors, indicate the surname of the first author followed by "et al." and the year of publication.

Websites must be cited in lowercase roman type when the full address is provided (e.g., <http://www.sitointernet.com>). If only the website name is indicated, it must be written in italics, without quotation marks, as for the title of a journal or newspaper (e.g., *Libraweb*; *Libraweb.net*).

Tables (maximum 2) must be numbered using Roman numerals (Table I: XXXX), inserted directly into the text, and provided with a caption.

The figure (maximum 1) must be numbered using Arabic numerals (Figure 1: XXXXX), in black and white or color, with a resolution of 300 dpi and provided with a caption. Font sizes and the thickness of axes or lines must ensure good readability during printing or on-screen viewing. Only “sans serif” fonts (e.g., Arial, Tahoma, Futura, etc.) with a size of 8 points should be used in images.

References must be listed in alphabetical order. Journal titles must be abbreviated according to the Index Medicus guidelines. The maximum number of references is 3, numbered progressively.

For **web references** indicate the author's first and last name, the website URL, and the date of the last access to the page.
